- Consists of shares held indirectly by Fenway Partners II, LLC and Fenway Partners, Inc., of which the reporting person is a managing director. The reporting person disclaims beneficial ownership of such shares except to the extent of his pecuniary interest, if any, and this report shall not be deemed an admission that the reporting person is the beneficial owner of all of the reported shares for purposes of Section 16 or any other purpose.
- Shares acquired pursuant to Directed Share Program in connection with initial public offering of common stock of iRobot Corporation.
- This option vests over a five year period at a rate of 20% on the date listed in the table, and the balance vesting in equal annual installments over the remaining four years.
